Dear Chairman Johnson:

We write in further regard to your July 28, 2020 letter to Attorney General Barr and to Director Wray regarding the Crossfire Hurricane investigation and certain matters related to Ukraine.

As you are aware, the Attorney General has determined that it is now in the public interest to release to Congress additional documents and information related to these matters to the extent consistent with national security interests and with the January 7, 2020 order of the Foreign Intelligence Surveillance Court.

Enclosed with this letter is a submission of additional documents, Bates numbered DOJ-HSGAC20200728-000259 to DOJ-HSGAC20200728-000329. The attached production is unclassified in its current format. Pursuant to longstanding Department policy, the Department has made redactions relating to certain personally identifiable information or to ongoing investigations, enforcement activities, and certain law enforcement operations, methods, or techniques.

Today's submission is based on extraordinary and unique circumstances, and should not be construed as precedent setting in any regard. The production of these materials does not waive any applicable privilege.

# Manafort Chronology

---

**1970s:** Trump met Manafort through Roy Cohn

**1995 December 17:** Konstantin Kilimnik and Philip Griffin were among the International Republican Institute staff members working on the observation mission for the Russian parliamentary elections.<sup>1</sup>

**1999 October:** Aleksei Kiselev founds(?) Eurosoft, based in "Washington DC" (FINRA)

- **1999 October 21:** Eurosoft International Inc. registers in Dover, DE, file number 3114792 (20May16)

**2002 August:** Aleksei Kiselev begins working for North Atlantic Securities LLC, Scarborough ME (FINRA)

**2003:** Aleksei Kiselev hired Venable, DB and other PR firms for planned Yanukovych campaign visit to US.

**2004 June:** Konstantin Kilimnik is among the International Republican Institute program officers in Russia who were interviewed by ARD Inc. for a USAID project on the status of democracy in Russia.<sup>2</sup>

**2004 September:** Candidate Yushchenko is poisoned, likely by SBU officials, possibly organized by Eduard Prutnik and Andrey Klyuyev on orders of Russian PR man Gleb Pavlovskiy (20May16).

**2004 October:** Aleksei Kiselev led delegation of ex-Congressmen to Kyiv to declare first-round elections fair.(20May16)

**2004 November:** Eduard Prutnik, a Yanukovych aide, held a raucous conference at the National Press Club. Aleksei Kiselev "translated."

**2004 December:** Yanukovych belatedly asked for help to save his presidential candidacy, according to Manafort.

**2004 December 26:** Yushchenko defeats Yanukovych in new round of election.

**2005:** Akhmetov asked Davis Manafort to groom SCM's image

**2005:** Manafort and Davis got Sen. John McCain to lobby for Montenegro independence, on Deripaska's behalf<sup>3</sup>

**2006 4 January:** Colberg Projects LLP registered in the UK. It owned TechCorp, which owned ChorneMore LLC

**2006 January 25(?) :** Rick Davis arranges for Oleg Deripaska to meet with John McCain on the sidelines of the Davos conference in Switzerland.

- Afterwards Deripaska writes a thank-you note saying, "Please will you send me the information on the metals trading company we discussed and would be happy to see if I can do anything to help."<sup>4</sup>
- "In November 2005, Pegasus [Capital, which Davis unofficially advised, had] bought a stake in a company called Traxys, which trades in industrial metals."

**2006 May 21:** Montenegrin independence referendum. Rick Davis had advised the ruling party.

**2006 August 11:** Konstantin Kilimnik, longtime employee of the International Republican Institute, chaired by John McCain, is on the list of Davis Manafort people approved by the Election Commission of newly independent Montenegro to monitor its 10 September election.<sup>5</sup>

**2006 August (circa 29th):** Davis, McCain and Deripaska were reportedly all present at a party in Montenegro and an afterparty on a yacht where the group toasted McCain's 70<sup>th</sup> birthday, which fell on Aug 29.

- McCain was there on a Senate trip organized by the Montenegrin government.
- The government probably invited Deripaska because he was the country's biggest employer.
- "Davis was a paid consultant to the governing party in Montenegro."<sup>6</sup>

**2006:** Manafort buys apt in Trump Tower—some say as cover for Deri and/or Firtash

**2006 Dec 7:** Pericles Investors Ltd was incorporated.

**2007 March 9:** Pericles Emerging Market Partners LP is formed from Altimax (replaced by Surf Horizon Ltd—Deripaska) and Pericles (Manafort)<sup>7</sup>

**2007 March 28:** Alatau Hospitality –potential partner with Manafort’s CMZ and Pericles--is registered in Cyprus at an address used by Vekselberg, Akhmetov and other FSU oligarchs.<sup>8</sup> and based in **Dubai**<sup>9</sup>.

**2007:** Davis Manafort groom Party of Regions for Sept parliamentary elections. Yanukovich fires them at last minute.

**2007 October:** Aleksei Kiselev begins working for “Pericies LLP” [sic] (FINRA)

**2008 April:** Eduard Prutnik and Aleksei Kiselev found One World (United World) Humanitarian Foundation (20May16)

**2008 April 15:** Deripaska’s Surf paid \$18.9mln to PEM advisors to fund acquisition of Chorne More telecoms by the Pericles Emerging Markets Partners LP.

**2008 April 22:** PEM paid Andrey Vityukov, a partner of the Cherep brothers who formerly owned Chorne More before TechCorp ostensibly took it over.

**2008 April 23:** Gates told Surf he had bought Chorne More entities

**2008 June:** Gates met with Deripaska aides Andrey Zagorskiy and Anton Vishnevskiy in Moscow to discuss Pericles’ participation with Alatau and Inovalis in the Drake Hotel project

**2008 June 9:** Paul Manafort registers “XXX LLC” in Delaware. Later in June it would be a co-owner of CMZ Ventures LLC (aka ZMC ventures—initials stand for Arthur G. Cohen, Paul Manafort, and Brad Zackson), a company with Dmitriy Firtash and

Semion Mogilevich as silent partners, used to launder funds, according to a Yuliya Tymoshenko's lawsuit.<sup>1011</sup>

**2008 30 June:** Manafort met with Deripaska to discuss Pericles partnership investment in Drake Hotel/Bulgari Tower.

**2008 July** Firtash's DF claimed to be planning to buy the Drake Hotel (Bulgari tower) and St. Johns Terminal, and South Cat Cay Island, Bimini, Bahamas, near Miami, according to Yuliya Tymoshenko's lawsuit. (Had Deripaska turned them down, or was DF behind one of the other planned buyers, Alatau or Inovalis?)

**2008 July 16:** CMZ (Manafort/Cohen/Zackson/Firtash/Mogilevich?), Alatau and Inovalis (jointly known as CAI) sign letter of intent to purchase Drake Hotel, promise to deliver \$10mln deposit within 10 days.<sup>12</sup> (No mention of Deripaska or Pericles).

**2008 July:** Representatives of Deripaska's Surf Horizons met Manafort's aide Gates in Ukraine and toured the PEM Advisors office and the purported Chorne more offices [in Odessa], as if to show that PEM had indeed bought the company.

**2008 August 20:** Brad Zackson writes to Harry (Macklowe? Drake Hotel owner) and Arthur (Cohen? Of CMZ) saying he had had a meeting in Monte Carlo and firmed up CMZ's \$112mln in equity, as well as a commitment from Frank [Orenstein]/Alatau, "so we are adequately backed up in event of any shortfall."<sup>13</sup> No mention of Inovalis.<sup>14</sup>

**2008 November 6:** Firtash's DF group wired \$25 million from its Raiffeisen Bank account to CMZ Ventures, Calister Investments, and the Dynamic Fund as part of an escrow agreement for the Drake Hotel/Bulgari Tower project.<sup>15</sup>

**2008 Dec:** Manafort met with Firtash in Kyiv to discuss setting up Global Real Estate Fund which would ostensibly allow Firtash, Mogilevich etc. acquire real estate in the US, according to Yuliya Tymoshenko's lawsuit.<sup>16</sup>

**2009 Jan:** Drake Hotel/Bulgari Tower project sputtered

**2009 March:** Zackson wrote in an email, "I have an idea to bring [Donald] Trump in on the Drake."<sup>17</sup>

**2009:** Manafort grooms Yanukovych's image for 2010 Presidential Elections

**2009 June 8** Manafort emailed Zackson and summarized his recent trip to Kyiv to discuss additional foreign investments by Firtash, Mogilevich, Group DF, and their associates, according to Tymoshenko's complaint.<sup>18</sup>

**2009 December:** OPIC signs document renewing cooperation with Ukraine, says OPIC website (20May16)

**2010:** One World/United World (here transliterated Edynuy Svit) creates "Latvian-Ukrainian Trade House" with Vasil (or Vasy) Melnyk of Latvian company Eiroholdings (could be "Euroholdings").<sup>19</sup>

**2010 June:** OPIC and Prutnik sign document renewing cooperation with Ukraine, says One World/ United World (20May16)

**2011:** Tymoshenko filed racketeering lawsuit claiming Firtash, Manafort etc. conspired to launder funds through the United States under the guise of investing in development projects, with the goal of channeling the money back to Ukraine to bribe Ukrainian officials to persecute Tymoshenko. She does not highlight

Deripaska's role, though one of the exhibits pegs him as having been a potential Drake Hotel project partner in 2008.

**2012 August 24:** Skadden Arps reports to Manafort and receives Ukrainian govt input on findings of Skadden Arps investigation into Tymoshenko imprisonment.<sup>20</sup>

**2014 February 4-6:** Manafort is in Kyiv during the Maidan events. [Surkov is in Crimea around this time]

**2014 February 26:** Firtash arrested in Vienna

**2014: March 24:** Firtash (out on bail) met with Sergey Levochkin, Vitali Klitschko and Petro Poroshenko and urged them not to run against each other for President. He claims "the meeting was his idea and was aimed at preventing the presidency of Batkivschyna Party Leader Yulia Tymoshenko."<sup>21</sup> Poroshenko admitted meeting Firtash while in Austria for the birthday of Klitschko's brother Wladimir, who was born March 25.<sup>22</sup>

**2014 March 25:** Manafort flies (back) from Vienna to Kyiv.

**2014 August 9:** Ex-Manafort employee Konstantin Kilimnik, using the email address [REDACTED] writes to TV journalist Mariya Stolyarova with ideas for a video promoting the Party for Development of Ukraine, a project of Sergey Lyovochkin that would merge into the Opposition Bloc by September.

**2014 autumn:** Manafort reportedly worked for ex-boxer Klitschko's Kyiv mayoral campaign, recommended by ex-Presidential Administration chief Serhiy Lyovochkin.

**2014 autumn:** Manafort helps Opposition Bloc (remnant of Party of Regions) win seats in parliamentary elections

**2014 Dec:** Deripaska's Surf Horizons asked that the Cayman-based Pericles Emerging Market Partners LP partnership with Manafort be wound up.

**2015 autumn:** Sam Patten (former Manafort employee, later BGR Gabara? (Robert Amsterdam et al) advised Klitschko.

**2015 autumn:** Manafort tried to advise Opposition Bloc for local elections, frustrated by strife

1. Glen gave me a memory stick.
2. He identified Michael Cohen, a lawyer in Brooklyn w. Russian (Brighton Beach) clients, as the go-between from Russia to the Trump campaign who replaced Manafort & Carter Page. Cohen's wife's name is Shusterman. Her father is a major real estate developer in Moscow with ties to the Kremlin, Cohen may have attended a meeting in Prague, possibly in September, about this.
3. ~~Paet~~ Much of the collection about the Trump campaign ties to Russia comes from a former Russian intelligence officer (? not entirely clear) [redacted] Glen does not know his name.
4. A former Trump campaign official ~~Paet~~, possibly Rick Wilson, was talking about some of this and the Trump campaign tried to sue him for violating his non-disclosure agreement.
5. A Russian senator named Torshin, whose name came up in the Spanish money laundering investigation & who may also be involved in running the Central Bank of Russia, may have been involved in funneling Russian money to the NRA to use in the campaign. An NRA lawyer named [redacted] found out about the money pipeline and was very upset, but the election was over (to mobster)

These are pictures of Trump with Gen. Torshin. Torshin travels frequently to the US to meet with the NRA (he is a Tibetan member) & ostensibly works to loosen the gun laws in Russia.

6. Some of Glen's ~~sources~~ people believe that the NRA received an abnormally large amount of money to spend in the election, possibly indicating Russian involvement, but others disagree.

7. The ~~Atlanta~~ New York Times story on Oct 31 ~~about~~ downplaying the connection between Alfa servers and the Trump campaign was incorrect. There was communication and it wasn't spam. Mikhail Fridman ~~is~~ lied in written statements just he gave to the NY Times & Washington Post on this matter. Fridman claimed he never met Trump, but there are pictures.

8. Glen received a message ~~from~~ yesterday that   
 [REDACTED] He is not sure whether to believe this.

### **RUSSIA/US PRESIDENTIAL ELECTION- REPUBLICAN CANDIDATE TRUMP'S PRIOR ACTIVITIES IN ST PETERSBURG**

#### **Summary**

- Two knowledgeable St Petersburg sources claim Republican candidate TRUMP has paid bribes and engaged in sexual activities there but key witnesses silenced and evidence hard to obtain
- Both believe Azeri business associate of TRUMP, Araz AGALAROV will know the details

#### **Detail**

1. Speaking to a trusted compatriot in September 2016, two well-placed sources based in St Petersburg, one in the political/business elite and the other involved in the local services and tourist industry, commented on Republican US presidential candidate Donald TRUMP's prior activities in the city.
2. Both knew TRUMP had visited St Petersburg on several occasions in the past and had been interested in doing business deals there involving real estate. The local business/political elite figure reported that TRUMP had paid bribes there to further his interests but very discreetly and only through affiliated companies, making it very hard to prove. The local services industry source reported that TRUMP had participated in sex parties in the city too, but that all direct witnesses to this recently had been "silenced" i.e. bribed or coerced to disappear.
3. The two St Petersburg figures cited believed an Azeri business figure, Araz AGALAROV (with offices in Baku and London) had been closely involved with TRUMP in Russia and would know most of the details of what the Republican presidential candidate had got up to there.

**RUSSIA/CYBER CRIME: A SYNOPSIS OF RUSSIAN STATE SPONSORED AND OTHER CYBER OFFENSIVE (CRIMINAL) OPERATIONS**

**Summary**

- Russia has extensive programme of state-sponsored offensive cyber operations. External targets include foreign governments and big corporations, especially banks. FSB leads on cyber within Russian apparatus. Limited success in attacking top foreign targets like G7 governments, security services and IFIs but much more on second tier ones through IT back doors, using corporate and other visitors to Russia
- FSB often uses coercion and blackmail to recruit most capable cyber operatives in Russia into its state-sponsored programmes. Heavy use also, both wittingly and unwittingly, of CIS emigres working in western corporations and ethnic Russians employed by neighbouring governments e.g. Latvia
- Example cited of successful Russian cyber operation targeting senior Western business visitor. Provided back door into important Western institutions.
- Example given of US citizen of Russian origin approached by FSB and offered incentive of “investment” in his business when visiting Moscow.
- Problems however for Russian authorities themselves in countering local hackers and cyber criminals, operating outside state control. Central Bank claims there were over 20 serious attacks on correspondent accounts held by CBR in 2015, comprising Roubles several billion in fraud
- Some details given of leading non-state Russian cyber criminal groups

**Details**

1. Speaking in June 2016, a number of Russian figures with a detailed knowledge of national cyber crime, both state-sponsored and otherwise, outlined the current situation in this area. A former senior intelligence officer divided Russian state-sponsored offensive cyber operations into four categories (in order of priority):- targeting foreign, especially

western governments; penetrating leading foreign business corporations, especially banks; domestic monitoring of the elite; and attacking political opponents both at home and abroad. The former intelligence officer reported that the Federal Security Service (FSB) was the lead organization within the Russian state apparatus for cyber operations.

2. In terms of the success of Russian offensive cyber operations to date, a senior government figure reported that there had been only limited success in penetrating the “first tier” foreign targets. These comprised western (especially G7 and NATO) governments, security and intelligence services and central banks, and the IFIs. To compensate for this shortfall, massive effort had been invested, with much greater success, in attacking the “secondary targets”, particularly western private banks and the governments of smaller states allied to the West. S/he mentioned Latvia in this regard. Hundreds of agents, either consciously cooperating with the FSB or whose personal and professional IT systems had been unwittingly compromised, were recruited. Many were people who had ethnic and family ties to Russia and/or had been incentivized financially to cooperate. Such people often would receive monetary inducements or contractual favours from the Russian state or its agents in return. This had created difficulties for parts of the Russian state apparatus in obliging/indulging them e.g. the Central Bank of Russia knowingly having to cover up for such agents’ money laundering operations through the Russian financial system.
3. In terms of the FSB’s recruitment of capable cyber operatives to carry out its, ideally deniable, offensive cyber operations, a Russian IT specialist with direct knowledge reported in June 2016 that this was often done using coercion and blackmail. In terms of ‘foreign’ agents, the FSB was approaching US citizens of Russian (Jewish) origin on business trips to Russia. In one case a US citizen of Russian ethnicity had been visiting Moscow to attract investors in his new information technology program. The FSB clearly knew this and had offered to provide seed capital to this person in return for them being able to access and modify his IP, with a view to targeting priority foreign targets by planting a Trojan virus in the software. The US visitor was told this was common practice. The FSB also had implied significant operational success as a result of installing cheap Russian IT games containing their own malware unwittingly by targets on their PCs and other platforms.
4. In a more advanced and successful FSB operation, an IT operator inside a leading Russian SOE, who previously had been employed on conventional (defensive) IT work there, had been under instruction for the last year to conduct an offensive cyber operation against a foreign director of the company. Although the latter was apparently an infrequent visitor to Russia, the FSB now successfully had penetrated his personal IT and through this had managed to access various important institutions in the West through the back door.

5. In terms of other technical IT platforms, an FSB cyber operative flagged up the 'Telegram' enciphered commercial system as having been of especial concern and therefore heavily targeted by the FSB, not least because it was used frequently by Russian internal political activists and oppositionists. His/her understanding was that the FSB now successfully had cracked this communications software and therefore it was no longer secure to use.
  
6. The senior Russian government figure cited above also reported that non-state sponsored cyber crime was becoming an increasing problem inside Russia for the government and authorities there. The Central Bank of Russia claimed that in 2015 alone there had been more than 20 attempts at serious cyber embezzlement of money from corresponding accounts held there, comprising several billions Roubles. More generally, s/he understood there were circa 15 major organised crime groups in the country involved in cyber crime, all of which continued to operate largely outside state and FSB control. These included the so-called 'Anunak', 'Buktrap' and 'Metel' organisations.

The CROSSFIRE HURRICANE (CH) team proposes moving forward with its investigative efforts in a two-phased approach. The first phase will focus on additional investigative/analytical activity related to existing investigations. The second phase, which would proceed according to one of two options, would involve either new investigations and expanded areas of focus (Option 1) or overt steps to mitigate counterintelligence risk (Option 2).

**PHASE 1:**

**Timeframe:** November 2016 until approximately the end of December 2016

**Administrative:** Existing cases remain with current field offices, reporting directly to existing CH Team embedded within CD space. The CH Team will provide FBI executive management a written update once a week and briefings as requested. The CH Team will coordinate with DOJ on the below investigative steps as normal, but will only provide DOJ update briefings upon request.

- CH Team will pursue all available means to assess and validate Steele and the veracity of Steele's reporting. These steps include:

  - Completing a full analysis/review of reporting to identify all facts in the reporting that can be independently corroborated.
  - Conducting focused analysis, using all available sources, on the "quid pro quo" information identified in the Steele reporting.
  - Generate NSLs and conduct initial vetting of Steele information related to Michael Cohen under the CH umbrella investigation.

The team is now managing and working to deconflict these elements, and, as Paul indicated, we have a Public Corruption agent serving as the program manager for all of the Manafort lines of effort.*

*In coordination with EDVA and Money Laundering and Asset Recovery Section (MLARS), over [REDACTED] have been issued for [REDACTED] International Corruption investigation [REDACTED]. This involves alleged laundering of money stolen by Yanukovich and paid to Manafort via Cyprus.*

Multiple members of the team met with the agents and financial analysts involved in the international corruption investigation on April [REDACTED]. In a recent DOJ-negotiated meeting with the Associated Press, it was learned that AP had a source with information about a storage unit in Alexandria, rented to two partially-named individuals but paid by MANAFORT. [REDACTED] is investigating the storage unit.

*SDNY has its own mortgage fraud investigation of Manafort-owned properties in New York; this investigation also involves a named bank in Chicago. FBI has not been involved in this investigation to date – SDNY has been using its own 1811s.*

This case stems at least in part from open source reporting -- a February 2017 blog post by [REDACTED], a neighborhood blogger, who identified a townhouse in Brooklyn owned by Manafort. The property has large mortgage loans taken out against it exceeding value of the property. Three loans totaling \$16 million are associated with Federal Savings Bank in Chicago founder/chairman is Steve Calk, who per open source was an early Trump campaign supporter and named member of Trump’s Economic Advisory Council. Per open source, \$16M represents 5.4% of the bank’s total assets + 23.7% of total shareholder equity.

[REDACTED] MILES EDWARD TAYLOR, date of birth (DOB) [REDACTED], was interviewed at the DEPARTMENT OF HOMELAND SECURITY (DHS), 3801 Nebraska Avenue NW, Washington, D.C., by the writer and Special Agent [REDACTED]. After being advised of the identities of the interviewing Agents and the nature of the interview, TAYLOR provided the following information:

[REDACTED] TAYLOR is a Counselor to the Secretary of DHS. Previously, TAYLOR was a National Security Advisor to the Committee on Homeland Security in the U.S. House of Representatives. While in the latter position in approximately September 2016, TAYLOR received an e-mail from former National Security Advisor to the Committee on Homeland Security ANDREA THOMPSON, who asked if TAYLOR would meet with FLYNN INTEL GROUP (FIG) about a company FIG was representing. TAYLOR agreed and was subsequently put in touch with a FIG representative named BIJAN. [Writer's Note: BIJAN is one BIJAN R. KIAN.]

[REDACTED] On 29 September 2016, TAYLOR met with BIJAN and three representatives from GREEN ZONE SYSTEMS (GREEN ZONE) at the FORD HOUSE OFFICE BUILDING. Included among the GREEN ZONE representatives was one JUSTIN FREEH. The meeting concerned a form of communication technology featuring end-to-end encryption, which BIJAN pitched as having potential utility to special operations teams, domestic law enforcement, and members of Congress. During the meeting, and later by e-mail, BIJAN invited TAYLOR to FIG's offices for a demonstration of the technology.

[REDACTED] On 27 October 2016, TAYLOR traveled to FIG's offices at 44 Canal Center Plaza, Suite 400, Alexandria, Virginia, where he met BIJAN and representatives of GREEN ZONE, including FREEH. BIJAN led the presentation, during which the encryption technology was demoed by way of text messages sent between two phones. TAYLOR described the demo as useless given the abstract nature of the technology. Nonetheless, TAYLOR began asking various questions about the technology, which he had written down during the presentation. TAYLOR had asked about half of the questions in his notes when BIJAN announced to the group that he had invited others to join the meeting. At that time, the GREEN ZONE representatives left and three other men entered the room. No business cards were exchanged and nobody explained who the three

men were, though it was clear to TAYLOR that they were not with GREEN ZONE. Based on BIJAN's body language, TAYLOR believed that these men, rather than the encryption technology, represented the primary purpose of the meeting.

[REDACTED] BIJAN, again taking the lead, revealed that FIG had been conducting an investigation into FATHULLAH GULEN for months and, based on that investigation, FIG believed GULEN was a threat to the United States. BIJAN and the other men presented various names on whiteboards to illustrate GULEN's network, which included charter schools, organizations, and sub-organizations that collectively functioned as a financial vehicle through which all money went to the same place. No one explained how the information was collected, nor did anyone explain why the investigation was conducted. TAYLOR asked where there was any material support to a foreign terrorist organization and pressed BIJAN and the men as to why they felt GULEN was a threat. In response, TAYLOR was told that GULEN's plan involved long-term brainwashing in furtherance of jihad.

[REDACTED] After presenting the information, BIJAN told TAYLOR that Congress needed to take action and requested that the Committee on Homeland Security conduct a congressional hearing. BIJAN did not specifically ask for extradition. TAYLOR felt that the information was not sufficiently compelling and told BIJAN that they should go to law enforcement or other appropriate authorities if there was any indication of criminal wrongdoing. TAYLOR stated that GULEN was not relevant to the Committee on Homeland Security and told BIJAN that they were not the right committee for FIG. The meeting became awkward and ended abruptly. About one week later BIJAN e-mailed TAYLOR to thank him for meeting with GREEN ZONE; however, BIJAN did not mention GULEN.

[REDACTED] Prior to the meeting with FIG, TAYLOR did not believe he would be meeting with anyone acting on behalf of the Turkish government, and none of the men in the meeting stated that they represented a foreign interest. TAYLOR did not recall any reference to INOVO BV or any other company during the meeting. TAYLOR felt that BIJAN's conduct was not consistent with lobbying practices, as there was no documentation of their conversations and the GULEN presentation was sandwiched within a meeting with another firm (GREEN ZONE). According to TAYLOR, FIG's request for official action evinced a pedestrian understanding of the Committee on Homeland Security's function. TAYLOR also believed that FIG's subsequent filing under the Foreign Agents Registration Act (FARA) demonstrated little understanding of how The Hill worked.
